

Privacy Statement

Alisa Kresge Basketball Camp (“**Organization,**” “**us,**” “**we**”) respects your concerns about privacy. This Privacy Policy describes the types of personal information we collect about individuals through <http://alisakresgebasketballcamp.com/> (the “Site”), how we may use the information, with whom we may share it, and the choices available regarding our use of the information.

Information We Collect

We may collect personal information about you or your child, including:

- first and last name;
- school information, age, certain physical attributes and relevant experience; and
- contact information (such as your email address, postal address and phone number).

In addition, when you visit the Site, we may collect certain information by automated means, such as cookies. The information collected in this manner may include IP addresses, operating systems type, browser type, and other system settings. A “cookie” is a text file that websites send to a visitor’s computer or other Internet-connected device to uniquely identify the visitor’s browser or to store information or settings in the browser. Your browser may tell you how to be notified when you receive certain types of cookies or how to restrict or disable certain types of cookies. Please note, however, that without cookies you may not be able to use all of the features of our Site.

- respond to your inquiries; and
- send you newsletters or other communications about our program.

Sharing of Information

We do not share or otherwise disclose information about you except as described in this Privacy Policy. We may disclose information about you (i) if we are required to do so by law or legal process (such as a court order or subpoena), (ii) in response to requests by government agencies, or (iii) when we believe disclosure is necessary or appropriate to prevent physical harm or financial loss or in connection with an investigation of suspected or actual illegal activity.

Children’s Personal Information
